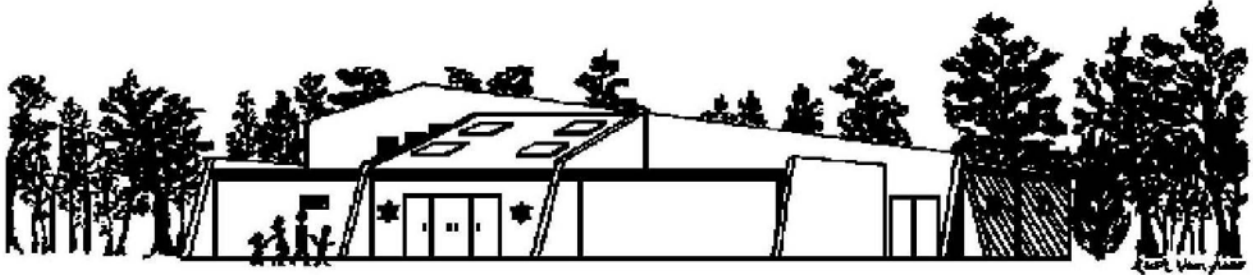

## Notes:

- Membership becomes final by vote of the Temple Board of Trustees. New members will be notified in writing following the vote of the Board. Board meetings are generally held the third Thursday of each month.
- You are responsible for all monthly dues through and including the month that you submit your written resignation to the Temple Board of Trustees. You are liable for religious school tuition regardless of when you resign from the Temple or withdraw your child(ren) from the school.
- **The Temple asks prospective new members to enclose a payment equaling two (2) months of dues and fees when submitting this application.**

# B'nai Israel Reform Temple Dues Structure

Effective July 1, 2022

## Category Descriptions

**Full/Regular (couple)** is a membership where both adults cannot qualify for any of the types listed below.

**Type I (couple)** is a membership where both adults are under the age of thirty-five. This type of membership shall terminate on the first day of the month that either adult reaches the age of thirty-five or when the couple has been in the type for a period of three years, whichever comes first.

**Type I (individual)** is a membership where the individual is under the age of thirty-five. This type of membership shall terminate on the first day of the month that the individual reaches the age of thirty-five, or when the individual has been in the type for a period of three years, whichever comes first.

**Type II (couple)** is a membership where both adults are retired or otherwise no longer gainfully and actively employed, and either individual has reached the age of sixty-two or age fifty-five and has been a member for five years or more. The Board may waive the age requirement if retirement is due to a disability and the person is no longer employed.

**Type II (individual)** is a membership where the individual is retired or otherwise no longer gainfully and actively employed, and has reached the age of sixty-two or age fifty-five and has been a member for five years or more. The Board may waive the age requirement if retirement is due to a disability and the person is no longer employed.

**Type III (individual)** is a membership with one adult who cannot be considered in Type I (individual) or Type II (individual) described above.

## Fee Explanations

**Building Fund:** The Building Fund levy of \$600.00 is due upon joining the Temple or you may choose to spread the payment of the levy over four years. However, the levy must be paid in full prior to your first Bar or Bat Mitzvah celebration or your resignation.

**General Fund Assessment:** This fee is evaluated on a regular basis and will remain in effect unless changed by the Board of Trustees with approval of the Congregation.

**Religious School:** Religious School tuition is due at registration. It is in addition to your membership dues, fees, and assessments.
